

Manuscript Information For Authors: *Journal of American Physicians and Surgeons*

MANUSCRIPTS

Manuscripts are accepted for publication on the condition they are contributed for first-time use in the *Journal of American Physicians and Surgeons* and with the understanding that the author has permission from the copyright owner to reproduce or adapt any previously published text or figures.

Manuscripts should preferably be submitted via e-mail to editor@jpands.org. Alternatively, manuscripts may be submitted to AAPS on a 3.5-inch disk in format compatible with Microsoft Word, or in ASCII or Rich Text Format. Include postal address, telephone and fax numbers, and e-mail address (if available) for the corresponding author with all submissions. Hard copy (double-spaced) should accompany the diskette. Do NOT insert formatting codes.

Receipt of all manuscripts and media materials will be acknowledged if a self-addressed, self-stamped return envelope is supplied, or by e-mail if submitted in that manner. Manuscripts and diskettes will not be returned.

The Journal will consider for publication original investigations (typical length 2,000 to 4,000 words, exclusive of tables, figures, and references), reviews (2,000 to 4,000 words), commentaries (750 to 2,000 words), brief reports of clinical cases (750 to 1,500 words), and book reviews (500 to 1,000 words). Letters to the Editor should be less than 500 words.

The Journal cannot be responsible for the cost of converting hard copy into a usable electronic file.

STYLE

For general guidelines on manuscript preparation, see the Uniform Requirements for Manuscripts Submitted to Biomedical Journals, available at www.icmje.org.

All manuscripts are subject to copy editing to conform to AAPS style.

References must be numbered consecutively as they are cited in the text. Each reference is to be listed only once; multiple citations to a single article should all use the same number. Place the number after the text to which it refers, either as a superscript or on the line of text in square brackets. Please do not use the endnote feature of your word processor in the submitted article.

Numbered references to "personal communication" or "unpublished data" may not be added to the reference list. If essential, such material should be included in the text in parentheses. A date should be cited for personal communications, for example: (Faria MA, personal communication, 2002). List numbered references at the end of the article. Include all authors if there are five or fewer; otherwise, list the first three followed by et al. Abbreviate journal names as in the *Index Medicus* (www.nlm.nih.gov/tsd/serials/lji.html).

References should be cited in the following format:

Journal article: Ravnskov U, Allen C, Atrens D, et al. Studies of dietary fat and heart disease. *Science* 2002;292:1464-1465. [Cite issue only if pagination is not continuous throughout a volume: vol(no.) or vol(month).]

Book chapter: Rutter M. Diagnosis and definition. In: *Autism: A Reappraisal of Concepts and Treatment*. New York, N.Y.: Plenum Press; 1978:1-25.

Article on internet: CDC. Dengue fever. Nov 10, 2003. Available at: <http://www.cdc.gov/ncidod/dvbid/dengue/>. Accessed Jan 28, 2005.

Book: Ottoboni, A, Ottoboni, F. *The Modern Nutritional Diseases*. Sparks, Nev: Vincente Books; 2002.

Illustrations must be in suitable electronic format or of a quality suitable for reproduction (i.e., high-contrast black and white glossy prints). Tabular data should not duplicate material in the text.

ETHICAL REQUIREMENTS

Conflicts of interest: Authors must supply a statement of potential or perceived conflicts of interest relevant to material of the article, including government, foundation, or corporate grants; consultants' or speakers' fees; stock ownership; membership on Boards of Directors or Trustees of corporations or foundations; government, foundation, or corporate employment or contracts. If there are no such potential conflicts, the author should so state.

Data access: For reports containing original data, authors must provide access to the data for reanalysis by interested scientists, with appropriate protection of patient identities, in the interest of assuring integrity, furthering open discussion and scientific progress, and facilitating the self-correcting mechanism of science.

GENERAL POLICY

Proofs: Galley proofs will be submitted to the authors for correction and prompt return (within 48 hours).

Copyright and Reprints: AAPS holds the copyright on all material published in the Journal. Permission is granted to reprint, providing that the journal is properly cited, with date, authorship, copyright notice, and postal address and URL of AAPS.
