## Ten Principles of Health Care Policy By Joseph L. Bast

The proper role of government in financing and delivering health care is one of the hottest public policy issues of our time. Some experts call for more regulation and more subsidies, while others call for less.

All levels of government in the U.S. are coping with rising spending on health care for their own workforces and rapidly rising spending on programs for the poor and elderly.

This booklet can help state legislators find solutions to health care problems by identifying their causes and true extent — which often are not as they are reported in newspaper stories or touted by special interest groups — and then presenting 10 principles that should guide reform efforts.

This 39-page booklet challenges the widely held assumption that health care is a "right" rather

The author also challenges the notion that government can determine the "right" amount of spending on health care.

Practical solutions to problems of price, access, and quality in health care can often be found by repealing existing laws, rather than adding new ones, and reducing public reliance on third-party payers for insurance and health services. Other recommendations include ways to control the price of drugs, reduce malpractice litigation, and encourage people to purchase long-term care insurance.




